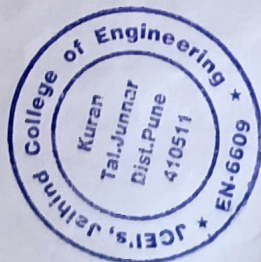

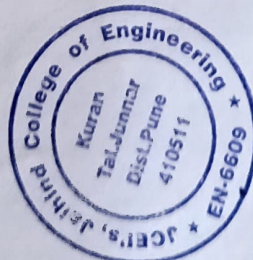

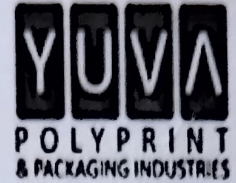

### WHEREAS:

A) First Party is a Higher Educational Institution named: **Department of Electronics**





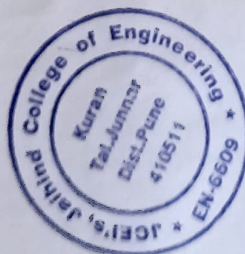

- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Industrial Visit, Expert Lectures.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;
- E) **Yuva Polyprint and Packaging Industries, Sangamner** the Second Party is engaged in Manufacturing & Packaging

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

**CLAUSE 1: CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty and Students of First Party providing significant inputs to them in developing Industrial work and Automation and Skill Development in mind the needs of the industry/ the Second Party.





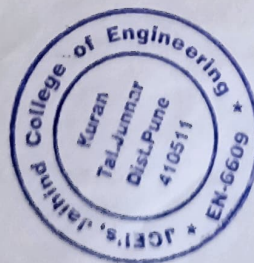
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

## CLAUSE 2: SCOPE OF THE MoU

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

- 2.2 **Industrial Training:** Industry interaction will give an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to industry oriented skill development training and also involve in Industrial Training Programs. The Skill Development training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The applicable charges (if any) for the same will decide and paid on mutual consent.

- 2.3 **Skill Development Programs:** Second Party to train the students of First Party






on the emerging technologies in order to bridge the skill gap and make them industry ready.

2.4 **Guest Lectures:** Second Party to extend the necessary support to deliver appropriate guest lecturers to the students of the First Party on the technology trends and in house requirements.

2.5 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting industrial exposure/ training as per the industrial requirement considering the National Occupational Standards in concerned sector.

2.6 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein.

2.7 Neither party shall have any financial commitments to the other, under this MoU. Such financial commitments, if any, shall be dealt with separately.



### CLAUSE 3: VALIDITY

3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms. During this period **Yuva Polyprint and Packaging Industries, Sangamner**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Yuva Polyprint and Packaging Industries, Sangamner**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU vice versa.





3.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing.



## Obligation of Work – ProAzure

Either Party shall not use logos, trademarks, trade names or intellectual property of other Party for any other purpose as enshrined under this MOU without prior written approval from other Party.



1. Either Party shall ensure that nothing is done or omitted to be done by them which may affect the reputation of other Party or its intellectual property.
2. The Parties hereto agree that they are independent contractors. Nothing contained herein shall construe either Party as an agent, legal representative, partner, subsidiary or employee of the other.
3. Each party shall be at liberty to terminate this MOU with a written notice period of 60 (sixty) days / (2) months to the other party without any compensation and seeking legal redress.
4. In case of termination of this MOU, ProAzure agrees to fulfil their commitments towards the enrolled students and to complete the remaining training for the particular semester.
5. All claims, disputes, differences or disagreements of whatsoever nature arising out of, in connection with or in relation to this MOU whether during its term or after expiry thereof or prior termination, shall be finally decided by arbitration to be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996 in force as at the date of the invocation of the arbitration.
